RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the racing surface, pit areas, infield, burn out area, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any event) EACH OF THE UNDERSIGNED, for themselves, their personal representatives, heirs, and next of kin acknowledges, agrees and represents that he/she harm or will immediately upon entering any of such restricted areas, and will continuously thereafter inspect such restricted areas and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that their entry upon such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgment that he/she has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of their use, and he/she further agrees and warrants that if, at any time, he/she is in or about

- restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas.

 1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT SUE Western Racing Association, its officers, the promoter, participants, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct any event and each of them, their officers and employees, all for the purposes herein referred to as "releasees" from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage and any claim or demands therefore on account of injury to the person or property resulting in death of the undersigned, whether caused by the negligence or the releases or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event:
 - HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise:
 - HEREBY ASSUMES FULL RESPONSIBILTY FOR THE RISK AND BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while operating, observing, or working for or for any purpose participating in any event:
 - HEARBY RELEASES to Western Racing Association the right to use a picture, video, or likeness of me and/or my race car for any promotional purpose Western Racing Association chooses

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, not withstanding, continue in full legal force and
